Glasgow Pride Festival 2025

Salijon Abdurakhmonov, Uzbek Critic Jailed for a Decade After Disputed Conviction, Dies



Salijon Abdurakhmonov, an Uzbek journalist, human rights defender and former prisoner of conscience, has died aged 75. He was convicted after an unfair trial (drugs were alleged to have been planted in his car) and spent nearly 10 years in prison. He was released in 2017 and moved to Germany, where he died last month. He was sadly unable to clear his name.

The Taliban regained power in Afghanistan in 2021. Over the last 4 years, they have introduced increasingly devastating restrictions on the rights of women and girls, virtually erasing them from public and social life. Women and girls have been banned from attending secondary school, from working and earning a living, and from leaving their home without a chaperone. Any protests against the oppressive regime have been met with immediate violence. Despite this, women in and outside of Afghanistan continue to speak out.

Amnesty Feminists are passionate about advocating for the reinstallation and progression of women's rights through our **Rise With Afghan Women** campaign. Surviving Evin Prison Exhibition with Anoosh Ashoori (Perth Amnesty Group)



Surviving Evin Prison Exhibition: Perth 27th June -Sunday 6th July

We were delighted that **Anoosh Ashoori** made the effort to come to Perth to speak at the launch of the exhibition which describes in detail his experience of being held prisoner, without justification, in Iran's notorious Evin prison.

He talked movingly about the awful conditions he and his fellow prisoners had to endure. His account of the many days of relentless cowardly and barbaric interrogation was particularly chilling but gave us a vivid insight to the depths of depravity the Iranian regime has sunk.

We heard about and were inspired and in awe of the actions he took during his incarceration to see him through his ordeal. What he has done to rebuild his life on release and highlight the plight of hostages held across the world has been truly remarkable.

We invited the local MP, local City Councilors, Community leaders and Trade Union Representatives to the launch. Leaflets advertising the exhibition were distributed at various venues throughout the city. We are grateful to the ‘hands on’ practical help from Amnesty Scotland staff and Amnesty’s PR team for securing interviews for Anoosh with BBC Radio 4 and BBC Radio Scotland and the National Press about his prison experience and his presence at the exhibition’s launch. This media exposure, in particular, inspired a number of people to visit the exhibition as well as highlighting Amnesty’s role in its support for Anoosh to a national audience.

We were also grateful to staff and volunteers at St John’s Kirk, an historic building and visitor attraction in the centre of Perth, for making the space available for the exhibition, welcoming visitors, and providing catering at the launch.

Over 170 people were recorded as visiting the church and exhibition over its 9 day run.

- (b) AIUK AGM 5th/6th July -
- i. Thanks again to Clara, and Paolo, for making the G-form for us to vote on Signal as we got the motions through so late we couldn't do a meeting to discuss in the meeting, but could exchange views online - Feedback: "I found both of these things very straightforward and quick to do. Thanks to Paolo and Clara for setting up the online forms."

7. Legal Advice from AIUK on proscription of Palestine Action as a terrorist organisation by UK government 05.07.25 - please read here: [Gmail - Palestine Action Proscription Email from Sacha \(AIUK\).PDF](#)

Key Points:

- Emphasises the importance of the precision with which you will need to communicate so that nothing you say or do could be mis-interpreted or mischievously used to accuse you and your activism of supporting Palestine Action and, as a result, contravening anti-terrorism laws.
- As a very clear example; even though that prior to proscription, a statement (however expressed, in whatever channel) such as "We do not believe that the Government should proscribe Palestine Action as a terrorist group" was perfectly legal to say; from Saturday 5th July it apparently became an offence under the Terrorism Act even to say that statement.

- Even wearing a t-shirt which for example had a slogan supporting the proscribed organisation and wearing it in public would be an offence, and could result in anyone doing so being charged with a serious offence under the Terrorism Act.
 - To arrange or participate in a meeting (which is any get-together in any form of more than three people) that aims to discuss whether the proscription was right or wrong would be a criminal offence.
 - Please act as follows:
 - Do not proactively share information about the proscription of Palestine Action on any of your public Amnesty digital channels or in person events
 - Do not display logos, banners or any other promotional material related to Palestine Action at any of your Amnesty events
 - Do not discuss the proscription of Palestine Action at any of your Amnesty group/network or other meetings, including private meetings
 - Do not attend any meeting in your Amnesty capacity organised by others about or including Palestine Action
 - This is AIUK’s statement for use if you are asked about Amnesty’s position on this issue. *“In light of legal advice we have received regarding the effect of UK anti-terrorism laws, we are no longer in a position to comment on the proscription of Palestine Action. We are, however, able to continue commenting on the state of counter-terrorism law in the UK and its implications for human rights. It has been Amnesty International’s long-held view that the UK has a deeply flawed and overly broad definition of terrorism and overly broad and excessive restrictions on freedom of expression in relation to proscribed groups. Terrorism legislation hands the authorities massive powers to arrest and detain people, suppress speech and reporting, conduct surveillance and take other measures, such as criminalising holding a private work meeting that could be characterised as ‘supportive’ of a proscribed group. These sorts of restrictions would never be permitted in other circumstances and create a chilling effect on people’s freedom of expression and right to protest. Where necessary and proportionate, existing criminal laws accompanied by human rights protections, are more than adequate.”*
8. Due to advice received, we are unable to discuss this in our group meeting and can’t make comments specifically about PA. Those wishing to know more can read [AIUK’s press release](#) (from before the proscription), or can contact AIUK or their MP for further clarification. We *can* discuss the right to protest in general and if anyone would like to focus on group actions on this moving forward. AIUK has ‘Protect the Protest’ as one of its strategic priorities. It also published a major report a while ago, detailing numerous deficiencies in the design and implementation of the UK Govt’s ‘Prevent’ anti-terrorism strategy. As indicated in the UK advice, it seems that these broader themes will be the approach that the national AI organisation and local groups will take forward in campaigning.

10. **Email from AIUK re. Amnesty Global Assembly Consultation – Meetings on 16 and 17 July**

The Global Assembly is Amnesty International’s highest decision-making body. Comprised of delegates from every national Section and entity in the worldwide

movement, it decides on major questions of global strategy, finance, governance and policy. This year, the Global Assembly will be asked to make some significant decisions on Amnesty's global governance. Ahead of the meeting, which takes place on 25-27 July, the Board and UK delegation are keen to share the motions that will be discussed and hear from AIUK's activists. → **two on-line consultation meetings** have been arranged, taking place at **6.30pm on Wednesday 16 July and 6.30pm on Thursday 17 July**. The meetings will last for approximately ninety minutes and we will describe how the Global Assembly fits into Amnesty's governance, outline some of the key debates and, most importantly, listen to the perspectives of interested members. The motions will be dispatched to all those who register for these consultation discussions as soon as possible.
